The Supervisor stated the purpose of the meeting was to discuss how to use the remaining COVID money. We have \$183,557.90 left.

Councilman Gilbo stated he has done some research on cabins for Bulwagga Bay; the manufacturer in Keeseville is more favorable; 12 X 42; fully customized; \$33,000. Councilman Gilbo will meet with Rich Lapier tomorrow morning to see what would need to be done to make them 4 seasons. Councilman Anderson asked how much the Cedar cabins were and Councilman Gilbo stated they were \$89,000. Supervisor Brassard asked if \$33,000 was for a complete cabin and Councilman Gilbo state no, no insulation. Councilman Salerno stated he would like to put a pocket door in them so there can be a bathroom and Councilman Curran stated it is \$33,000 and there is no bathroom? Councilman Gilbo said no. Councilman Salerno stated he feels location is key also, which beach and Councilman Gilbo asked how close the water and sewer was to the cabins at Bulwagga Bay and Councilman Salerno stated he thought about 160 feet away; he felt we could fit one unit in by the bathroom up on the hill. Councilman Anderson asked if we would need a leech field and Councilman Salerno stated no, we would tie in to the Town water and sewer. Councilman Anderson asked if we are looking at 3 cabins; he thinks with site work it would cost around \$50,000 for each cabin. Councilman Gilbo asked how much the cabins made us this year and the Supervisor stated he thought one was \$9,000 and the other one was \$5,000.

Councilman Salerno stated he still feels we should renovate the beach house at Champ RV Park; easily get 2 rental units in there; for roughly \$40,000. Councilman Gilbo stated we would have to purchase the materials to support this idea and the Supervisor said yes, we could set aside \$50,000 for the Champ RV Beach House renovation. Councilman Gilbo asked if there was water and sewer there and Councilman Curran said yes. Councilman Anderson stated if we do the site work ourselves that would bring the price down; Councilman Salerno agreed.

Councilman Salerno would like to look at a gazebo for Powerhouse Park; the Supervisor stated he did; it would cost @\$6,000. Councilman Salerno stated the previous Supervisor always wanted to put a new roof on the Town Hall; also, what about a sidewalk machine.

Jamie Wilson-Highway Superintendent stated he gave the board information on a new skid steer.

They did get the sidewalk machine running. Mr. Wilson stated it is a 49 horse power for \$39,805 and we can also trade ours in; we would keep our attachments.

The Supervisor stated Councilman Gilbo wanted a breakdown of the difference between the dollar raise and a percentage raise. The Supervisor stated elected official salaries can't change because they have already been posted. Councilman Gilbo stated the difference over 3 years would be @\$20,000. Councilman Salerno stated if the Board decided tonight would it be for a 3-year contract and the Supervisor said yes. Councilman Salerno stated if it is voted down, we would have to hire a lawyer and go to arbitration. The Supervisor stated both sides would have to hire lawyers, etc. Councilman Gilbo stated he would never vote for more than a 3 ½% raise again. Councilman Salerno stated we are in a tough spot because of the lack of workers; he asked the Supervisor if they could strike and the Supervisor said no. The Supervisor proposes for the non-union employees to get whichever raise is to their benefit; the dollar or the percentage. Councilman Anderson stated arbitration scares him; he stated we could lose. Councilman Gilbo and the Supervisor both stated for the non-union employees to get whichever raise to get whichever raise works best for them.
